## October 3, 2023

The monthly parent forum regarding grading and assessment was moved from September to October due to time constraints.

The Anti-Defamation League (ADL) gave school-wide training to students on September 26. It went well and the students were engaged in the programming. Takeaways will be completed in Student Council and Shark Blocks.

The \$2m grant received last year is to be distributed over the next 5 years. The funds are being utilized so far for more fish, aquariums and aero gardens, updates to technology such as underwater lenses for photography, the ADL, staff training, project-based learning, additional shark block activities and the rowing team.
